Oakwood Avenue – One Way, from the intersection of Livingston Street to the intersection of Chatham Street from 7:45 – 8:45 a.m. and 1:45 – 2:45 p.m., with a Do Not Enter sign at the intersection of Oakwood Avenue and Chatham Street.

Ontario Street – One Way, from the intersection of Linwood Street to the intersection of Tapley Street from 7:45 – 8:45 a.m. and 1:45 – 2:45 p.m., with a Do Not Enter sign at the intersection of Ontario Street and Tapley Street.

Holland Avenue – Right Turn Only at the intersection of Hood Street from 7:15 – 8:15 a.m. and 1:15 – 2:15 p.m.

Trevitt Avenue – Right Turn Only at the intersection of Park Road from 7:45 – 8:45 a.m. and 1:45 – 2:45 p.m.

Clinton Street – Left Turn Only at the intersection of Oakwood Avenue from 7:45- 8:45 a.m. and 1:45 – 2:45 p.m.


