**DUMPSTER/ TOTER PERMIT APPLICATION**

*Pursuant to Lynn City ordinance, no dumpster shall be placed on any private property<sup>1</sup> without a permit issued by the Board of Health. Areas surrounding dumpsters shall be kept clean and litter free; dumpsters shall be maintained clean and free of offensive odors and shall be closed when not in use. No person shall dispose of the contents of a dumpster between 7 p.m. and 7 a.m. without express authorization by the Board of Health.*
